On October 14 in the offices of Via Francesco Crispi 66, in Trieste, in the presence of the Lords:

Alessandro VALERIO, born in Reggio Emilia (Italy), on 02.05.1960, which is as a citizen of the Free Territory of Trieste since 03/08/1962

Graziano RISUGLIA, born in Lentini-SR (Italy) on 12/18/1975 as Citizen of the Free Territory of Trieste since 08/07/2016

Gian Gaetano CASO, born in Piedimonte Matese (Italy) on 02.25.1945 representing himself as Citizen of the Free Territory of Trieste since 08/07/2016

Marino GORI was born in Trieste on 05/01/1955, which is as a citizen of the Free Territory of Trieste from birth.

Ruggero GRIECO born in Trieste on 15/05/1958, Trieste, which is as a citizen of the Free Territory of Trieste from birth.

Eugenio PAROVEL born in Trieste, on 02.05.1959, which is as a citizen of the Free Territory of Trieste from birth.

Massimiliano BALDASSI born in Trieste, on 05.14.1971, which is as a citizen of the Free Territory of Trieste from birth.

Stefano BALDASSI born in Trieste, on 05/14/1971, which is as a citizen of the Free Territory of Trieste from birth.

Matteo PAROVEL born in Trieste, on 01/14/1995, which is as a citizen of the Free Territory of Trieste from birth.

We proceed to the Constitution of the Free Association in the Free Territory of Trieste (FTT), called International Committee Free Port of Trieste Conference (ICFPT Conference), in compliance with the resolutions passed by the International Committee of the Free Port of Trieste Congress (ICFPT Congress) the 09/03/2016.

The ICFPT Conference will be located in Trieste, Porto Vecchio, Warehouse 26, but will use a provisional office in Via Francesco Crispi 66, Trieste.

FINALITY

The association initially held the functions of Legal Entity Representative of the needs expressed by the citizens of the FTT, all gathered in several associations, which gave up in 1947 to accept any of the citizenships of Italy and Yugoslavia, ipso facto, not becoming stateless, but citizens its own country under UN auspices and therefore the international community with a special decree in international law.

The ICFPT Conference manifests the refusal of the Administration of the Free Territory of Trieste by the Italian Government, to the appeal of the Italian law on or relating to the Free Territory of Trieste, for refuted and affirmed, with silence / assent, "Nullity constitutional ", due to the lack of enforcement in the legal Ordinary Italian at Art. 117 of the Italian Constitution.

The ICFPT Conference will be engaged in the reintegration of the Jurisdiction of the Free Territory of Trieste, as defined in the 16th resolution of the UNSC and the Peace Treaty between Italy and the Allied Powers in 1947.

The Association will strive to obtain the recognition of the Legal Jurisdiction Sovereign through possessory action, however carried out in compliance with the law and the people, thereby affirming the sovereignty of the Free Territory of Trieste people, and in the territory, the Free port of Trieste.

The ICFPT Conference, intends to obtain the return to the control of the Government of the Free Territory of Trieste, and from the Port of Trieste, Trieste State Property, Cadastre Triestino including "Tavolare", managed by Vienna, Trieste and the Office of "Book foncier Triestino", because the property of Trieste Populations.

This is not only to encourage all economic activities of neighboring nations with speeches, that only if they come from "foreign" sources, are not amenable and manageable, the conditions agreed by the International Conventions; thereby intending to bring Peace, Safety and Well-being to all the populations concerned.

And also in order to ensure to all nations of the Italo-Balkan context, to take advantage of economic and, of those activities related to this case of the Free Port / Tax Free and a territory with its own jurisdiction.

ADDRESSES

Achieved the goal of the Representation Legal and Judicial, to date, for obvious reasons of international politics, clouded, the Association will cure the Government of the Territory in the name and on behalf of the citizens of the international community, it establish a government that will manage all activities social and economic.

The Government dell'ICFPT Conference must first of all ensure, in the Free Territory of Trieste, the citizen priorities are the safety and well-being.

These will be achieved through the Welfare and Healthcare, or rather setting policies of a security system - Pensions guaranteed and accumulated for all Residents, contract system, for all the residents, guaranteed dall'ICFPT Conference - to create the minimum being sought from all new born, regardless of nationality, color religion and his political orientation.

Safety will be exercised within the territory by a police force that will act to ensure internal security and, along with the police forces of the neighboring states, to ensure protection and respect for the law in the territory.

Outside the territory, especially in the United 8 former Yugoslavia, we will agree on the structuring of an Infrastructure Network, composed of highways linking Ports, Airports and Free Zones, among the eight States today interested in the Free Territory of Trieste, this will allow to put in peace and well-being even in boiling geo-political situation.

Security will also be secured by the agreements with neighboring states to which it will adopt the principles of subsidiarity and provides support in the development policies of other states, in every way that will from time to time agreed between the Institutional Stakeholders and the Zona Franca / Tax Free of the Free Territory of Trieste.

In the first of the Government Acts you will be required to:

- Constitution of **Register of citizens**, and its Regulations;

- Establishment of a **Chamber of Commerce** to regulate and publicize corporate and commercial activities, and the relevant Regulations;

- Reconstitution of **Demaniale and Cadastral Register** or of the "Tavolari Triestini", still managed by Vienna, but still prompted and essential to the definition of property in the Acts and Deeds Italian for the territory of Trieste, and its Regulations;

- The establishment of the **Register of Self-propelled**: Naval, Auto Moto Trucks Bus (already existing International Targa TS), and Aeronautical - with its Regulations;

- Establishment of a concessionaire company for the management of the Port of Trieste;

- Organization and control of a **police force** of FPT, and its Regulations;

- Organization of **economic and currency an Authority**, with all the regulated activities of competence.

The ICFT Conference therefore promulgates:

SEEING

The 16th resolution of the UNSC 1/10/1947

SEEING

The Peace Treaty between Italy and the Allied and Associated Powers of 10/02/1947, with special attention and reference:

Art. 21;

- In Annex VI - Permanent Statute of the Free Territory of Trieste,
- In Annex VII - which Instrument for the Provisional Regime of the Free Territory,
- In Annex VIII - Instrument for the Free Port of Trieste

SEEING

The refusal to appoint the new governor by the UNSC, to Italy and Yugoslavia specification of 05/20/1983, at the request of the Marchesich 20.04.83, because the Free Territory of Trieste is not recognized under nations that adhere to the UN

SEEING

The Osimo Treaty of 1975 between Italy and Yugoslavia, already technically challenged by Slovenia and Croatia with arbitration at the permanent court of arbitration at the ECHR Hague.

SEEING

The specific request of Italy and Yugoslavia no longer appoint a military governor for the Free Territory of Trieste

SEEING

The London Memorandum of 1992 between Italy and the former Yugoslavia

SEEING

The interventions of the Triest-Ngo in the UN plenary sessions (4) and then of shareholder statements in recognition of activities carried out by NGOs and the Association of Free Territory.

SEEING

The Statement of the Secretary General Ban Ki Moon released to the General Assembly in September 2013, and the UNSC on 10/23/2015

SEEING

The deposit at the Ordinary Court of Trieste, the Prefecture of Trieste, the Government Commissioner on the occasion of hearings relating to the jurisdiction of the Free Territory of Trieste belonging of summoned to the citizens of the Free Territory of Trieste; what therefore not prosecutable for the Italian jurisdiction.

SEEING

First Deposit in protocol ICFPT by Marcus Donato in qualtit president of PLT committee, with the UN deposit of 23/10/2010 with amendments 30/05/2011

SEEING

Opening at the UN, on 30/06/2016, the New Dossier Protocol, the Constitutional Declaration of Nullity for President of the Italian Republic of 11.7.2016, the state letter former Yugoslavia to the appeal of the Treaty of Osimo.

This will therefore proceed to promulgate the STATUTE:

Article 1

This statutory articulation is provisional.

Article 2

The Assembly is formed by citizens legally registered Anagrafe, and for this to all Members dell'ICFPT Conference effects. They will express their will by voting, when they called the organ of Government.

All citizens registered Anagrafe of the Free Port of Trieste, must register for a referendum vote to be able to democratically express their will.

The overt confirmatory referendum will, from time to time be a single subject.

The vote to get a majority will expressed by a majority of Members in the vote.

The vote with the relevant procedures will be controlled by the Councillor of the Interior, which will report the Body of Government, which shall determine the date, place and result.

Article 3

The Association's organizational chart, such as the composition of the Organ Government, corresponds to the procedures of the Free Territory of Trieste Government that will be expressed in resolutions or ordinances having the character of empire.

For the ordinary management of the business will rely mainly, of the Institute of Government Concession to qualified third parties or to the purpose contracts.

Article 4

The Governing Board is composed of ten delegates, including five listed by the UN Secretary General on a proposal from the Association and the remaining five appointed by the Association.

The Governing Body will regularly even formed with five members, and for covering absences, for various emerging title, will make use of the institute of Co-optation.

The Organ of Government will meet imperatively start of each week, with the Order of the Day from time to time prepared by the Secretariat

The organ of government is expressed by a majority.

The Organ of the Government is expressed without a chair, or in collegiate responsibility.

The Organ of Government will deal with the regulation of all activities that take place on the TLT, as well as entertain directly International Relations. The Board of Management will delegate responsibility to the Government Councillors, who may also be members Body Government, naming them by majority vote, to individual government activities, defining their addresses, the powers and temporal limits.

The Organ of the Government will indicate each time the Official Spokesman for every single task.

The Governing Body shall regulate the sessions of the Government with the appropriate Rules.

Article 5

E 'consists, in addition, the General Secretariat that will discharge the duties of coordination and control of the Departments, acting in the name and on behalf of the Government Body, and expressing, such as office, Imperii resolved.

The Secretary General is appointed by the Assembly.

The Secretary General participates in the meetings Organ of Government, providing for the preparation of the Minutes, emanates to their signatures the provisions and ordinances, for the application of the Organ indication of government through the publication of the implementing decrees.

The Secretary General has no vote, it will be called to express it only in case of a tie vote repeated in the Organ of Government.

The Secretary-General, when appointed, will be replaced only for his resignation that only a unanimous vote from the Organ of Government in plenary session.

Article 7

The Assembly of Founders appointed Secretary General in the person of Cdr. Gian Gaetano CASO.
